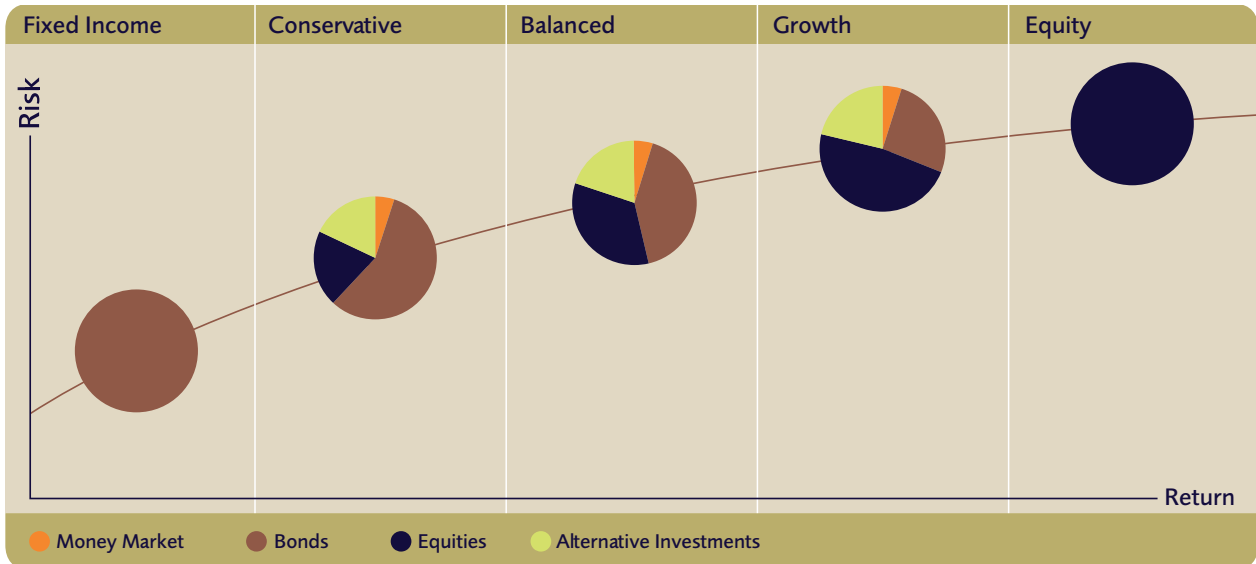

Fund Line: pure implementation through best-in-class collective investments.

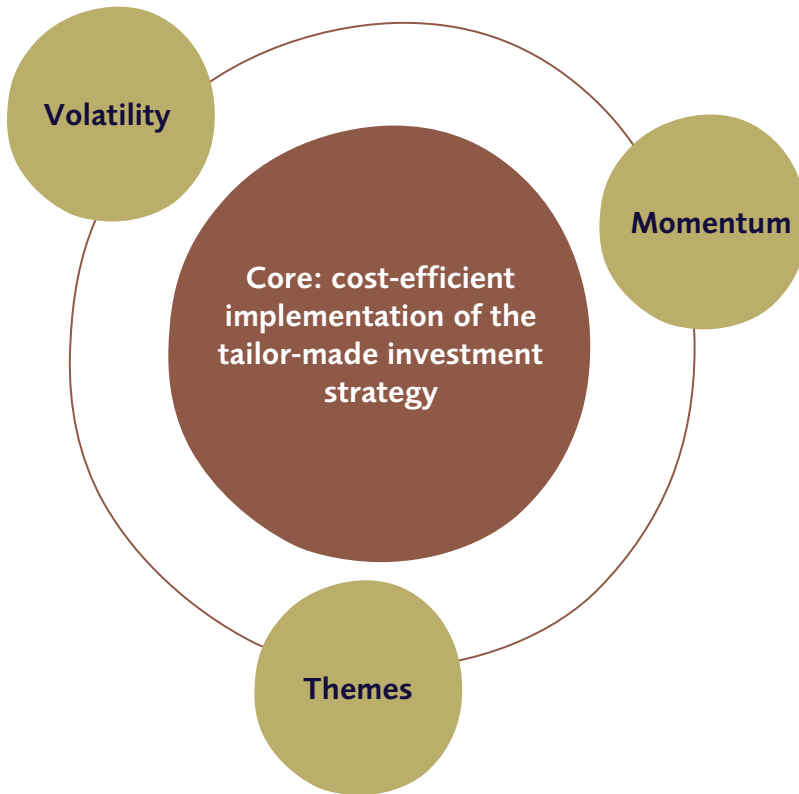
Special Mandates
